

STUDENT & PARENT/GUARDIAN INFORMATION LEAFLET (SURVEYS)

Purpose of the Study This study will explore students and teachers' experiences of a three-part workshop (film, post-film discussion, webinar): INTINN.

Why have you been asked to take part? You have been asked because you are a student interested in taking part in Cork International Film Festival's INTINN Project.

What will the study involve? Before taking part in INTINN, we kindly request that you complete a survey (see link below). After INTINN (e.g. a week or two), we will send you another link to complete another survey.

Do you have to take part? No.

If you are under 18 and if you do want to take part

- Please click on the link below (**Under 18 Form**)
- Have your parent/guardian read this information and sign the **parent/guardian consent section**.
- Then **you** sign the **assent section**.
- Then click on the **survey link** and complete the survey.

If you are 18 or over and if you do want to take part

BEFORE THE INTINN PROGRAMME

- Please click on the link below (**18 or Over Form**)
- Sign the **student consent form**.
- Then click on the **survey link** and complete the survey.

If you change your mind after completing the survey, and don't want to take part in the study, that's not a problem, but let me know within 2 weeks so I can delete your survey.

Will your interview be confidential? Yes! I will ensure that no clues to your identity appear in my reports. As per the assent form, an anonymous code will be used to hide your identity. This code will appear at the top of the survey.

How do I generate my anonymous code? Take the first three letters of the month you were born in, then the first initial of your first pet's name (if no pet, write "X"), then the last three digits of your phone number. So, if, for example, you were born in June, you never had a pet, and your number is 081-876429, your code would look like the below:

What will happen to the information which you give? The information will be kept confidential for the duration of the study, available only to the research team. It will be

securely stored on an encrypted work computer. On completion of the project, information will be kept for a minimum of ten years and then all surveys will be deleted.

What will happen to the results? The information from the interview will go into a report. The study may be published in research journals and presented at academic conferences.

What are the possible disadvantages of taking part? I don't envisage any negative consequences for your participation.

What if there is a problem? On the day of INTINN, should you become upset, there will be a teacher available to whom you can talk. We will also provide you with a list of supports with which you can engage. You may also wish to contact the researcher (see details below).
