Dear Parent(s)/Guardian(s)

Due to the demand from students and parents for After School Study I wish to advise that After School Study for 3rd, 5th and 6th Year students will commence on Monday, 7th September. Please see below the new rules for study and read over them with your daughter(s).

Students and teachers will be socially distanced and wearing masks for the duration of study. Windows and doors will be opened where possible to provide additional ventilation and your daughter should wear base layers to school if desired. These measures are in line with public health guidelines and if public health guidelines change we will react accordingly. There will be a fresh air break of 5 minutes during the 2 hour session.

5th and 6th Year students have the option to avail of after school study on three, four or five days per week. Friday study is limited to 5th and 6th year students only. 3rd Year students can avail of after school study on three or four days per week. Please select the days on which your daughter wishes to take part in after school study, by printing the form below and ticking the relevant boxes. Please note that once the days are nominated they **cannot** be changed. Study seats are **limited this year** and they are awarded on a first come first served basis upon receipt of payment. Each student will then be given a designated study seat.

Payment is due no later than Friday, 11th September, the chart below shows the breakdown of the cost. **All students must return the consent form below to Reception, in an envelope marked 'Supervised Study' to secure their place.** Please note that Our Lady's School has a facility for online payments through our website www.olschool.ie. Alternatively, a cheque should be made payable to 'Our Lady's School' and handed with the attached consent form to the Receptionist, in an envelope marked with the student's name, class and 'Supervised Study'.

It is strongly recommended that 3rd, 5th and 6th Year students avail of supervised study. The facility offers a structured, effective and consistent timetable for study in an

optimum environment.

Attendance will be taken on VSWare and will be available to parents for each session. If your daughter must leave study early permission to do so is required on the app.

After School Study Rules

Please note that there are new/amended rules for after school study 2020 which are in keeping with Covid 19 regulations:

1. Chromebooks and school laptops will be made available **where necessary** for after school study this year. Students may have the use of a device where necessary for a limited amount of time. The device must be cleaned before and after use by the student. These devices will be shared between students and appropriate cleaning must be undertaken by the student before and after use.
2. Mobile phones are not permitted during study for any reason
3. Study will run from 15.38 - 17.38 on Monday, Tuesday, Thursday (and Fridays for 5th and 6th years) and 14.00 - 16.00 on Wednesdays. The earlier finish allows students the opportunity to complete additional e-learning homework at home. IF the end of the school time is changed due to parent teacher meetings etc. the study times will change to reflect this.
4. All students must sanitise their hands on entering and leaving the study venue.
5. Students are permitted to eat in the study venue before the beginning of study. Desks must be cleared of all food and drink before study begins. No hot drinks are permitted in the study venues for health and safety reasons.
6. The microwaves in room 3 will not be available for any student to heat food.
7. Students will be assigned seats in the study venue and they must remain in their seats during this time. Bathroom breaks will be allowed but there can be no sharing of resources during the study session. Students will not be allowed to attend their lockers during the study session so they must come prepared.
8. Mobile phones are not allowed in any study venue.
9. If a student needs to leave early, parents must put a note on the app which will be made available to the study supervisor.
10. Masks/face coverings must be worn during the duration of study.

11. To avail of supported study, students must ask Ms. Campbell for a form which needs to be completed by both the student and the Year Head.
12. Students will not be permitted to attend their lockers once study has ended. They must exit the building via the emergency exit door assigned to their study venue.
13. There is a maximum of 49 places available to each year group for study. These spaces will be allocated on a first come first served basis upon receipt of payment. We will operate a waiting list. If you would like to sign up for study later in the term please contact Ms Campbell.
14. 6th Year study will take place in St Joseph's Hall, 5th Year study in the GPA, 3rd Year study in Lourdes Hall and Supported Study in Room 10.

Please note:

- It is important to the smooth running of study that these rules are observed. Failure to comply with them may lead to a suspension from supervised study.
- In the case of a special occasion where there is a half-day, there will be no study. However, in the case of school finishing early due to staff, parent/teacher or curriculum planning meetings, study will proceed twenty minutes after school ends. Such dates may be checked on the school calendar.
- Supervised study will not be available during the February exams.
