Dear Parent(s)/Guardian(s)

We hope you and your families are all well. We wish the 6th Year students the best of luck as they prepare for their graduation. We would also like to wish them every success in their future studies. Below please find some information that may be of help to you and your daughter(s) over the coming months.

The CAO change of mind facility is now open and will remain so until the 1st of July 2024, which is the final closing date. This allows students to review and amend their course choices. It is important that students have their CAO application and course choices correct and in their genuine order of preference by 1st July.

The students should receive a **Statement of Application Record** email from the CAO in May. It is vital that all correspondence from CAO is read and checked carefully and all instructions from CAO are followed. Failure to follow the instructions could result in students missing out on an offer. It is also worth noting that, following the 1st round of CAO offers, there may be a limited number of available place courses listed on the CAO website which students may apply to at that time.

Many students have applied and gained an offer to study at a **Further Education - Post Leaving Certificate (PLC)** college. It is important that students read carefully any correspondence they receive from their chosen college and follow any instructions given. Many colleges require payment of a deposit to secure a place. Once the results are released students should, if they wish to take a place in a PLC college, pass the details of their results to their chosen college and hopefully they will be in a position to take up their place. Applications for many **PLC courses and Apprenticeships** are still open and students can apply for these courses anytime between now and September 2024 if they wish to do so.

The college grants scheme, administered by SUSI opened for applications in April and will remain open until July 2024 for priority processing. Students are advised to apply as early as





possible using the online application on www.susi.ie . SUSI grants are available for students completing both CAO and Further Education - PLC courses. If your household income is below €100,000, it is worth checking if your daughter may be eligible on the www.susi.ie website.

Leaving Certificate results are due to be issued to students on **Friday 23 August 2024**. Please see the link below with the timetable of events for August from CAO. https://www.cao.ie/?page=timetableevents&bb=importantdates

We are awaiting further details of dates for the release of the component LC results, applications to view scripts, viewing of scripts in school/on-line & applications to appeal exam results. Updates will follow on www.examinations.ie
