Dear Parent(s)/Guardian(s),

I wish to advise that after-school supervised study sessions for 5th Year students will commence after the Christmas break on Monday, January 8th. Please see attached rules.

Study begins 20 minutes after school finishes i.e. on Mondays and Tuesdays study begins at 4.10 p.m. **sharp** and ends at 6.10 p.m. On Wednesdays and Thursdays study begins at 3.30 p.m. sharp and ends at 5:30 p.m. **There will be no study on days scheduled for staff meetings or when parent/teacher meetings are being held.**

The cost of this facility from January until the end of the year is €175. 5th Year students are also being offered an additional two-hour session on Fridays, from 3.30 pm to 5.30 pm. The additional cost of this facility is €50 .Payment is due on return after the Christmas break but no later than Wednesday, 10th January. A second daughter doing supervised study will pay at a reduced rate. Please note that Our Lady's School has a facility for online payments through Easy Payments Plus on our website www.olschool.ie . Alternatively, a cheque should be made payable to 'Our Lady's School' and handed with the attached reply slip to the Receptionist in an envelope marked with student's name, class and 'Supervised Study'.

As you are aware, your daughter is in the first year of the Leaving Certificate cycle .It is strongly recommended that 5th year students avail of supervised study as the facility offers a structured, effective and consistent timetable for study in an optimum environment

An electronic record of attendance will be taken on vsware and can be accessed by parents. Students are obliged to present a note to excuse them for any absence from the sessions throughout the term. If your daughter must leave study early a letter, written by you, should be given to the supervising teacher. In the case of an unexpected event the school must be phoned or an email can be sent to study@olschool.ie indicating the reason for the absence.

RULES FOR SUPERVISED STUDY

The following rules have been set in place in order to create the most favourable study environment for each student.

- (i) Students are expected to be punctual and to come prepared with all their books.
- (ii) No student will be allowed to the locker room after the study session has commenced.
- (iii) Students are not permitted to talk to each other at any stage of the session.
- (iv) Students are not permitted to pass books or copies to each other.
- (v) Students may drink water, however, all other drinks are not permitted.
- (vi) Students may not eat during the study period.
- (vii) If a student is absent, a note, signed by a parent/guardian, must be handed to the supervisor the following day.
- (viii) If a student needs to leave early, a note must be presented in advance.
- (ix) It is compulsory for students to bring their homework journals to every session.

It is important to the smooth running of study that these rules are observed. Failure to comply with these rules may lead to a suspension from supervised study.

In the case of parent/teacher meetings or staff meetings there will be no study. However, in the case of school finishing early due to a curriculum planning meeting, study will proceed twenty minutes after school ends. Such dates may be checked on the school calendar.
